HOW TO APPLY

- Have a GPA of 3.2 or higher
- Complete mandatory College of Wooster prerequisites with a B or better.

The deadline to apply for the Ohio 5 Business Collaborative is **May 15**. However, priority consideration for both admission and scholarships are given to candidates who apply by **Nov. 15**. Admission decisions will be provided within 30 days of application submission.

To apply, you must complete Weatherhead's standard application process in the second half of your junior year or at any time during your senior year.
